Appendix: Contestable and Non-contestable Services

Contestable services

Developers have a choice of who carries out certain activities on their sites. This is known as contestable work, and means that either the water company or another entity can carry out the activities. In certain cases, in order to meet our statutory obligations we will need to undertake the work ourselves. This document provides list of contestable services, which can be carried out by others. Relevant charges can be found in the Developer Services Schedule of Charges published alongside this document.

In addition to the options presented below, services relating to the provision of new water mains and sewers can also be provided by New and Variation (NAV) third party companies. Further details on the NAV market are available on Ofwat's website.

Sewer Requisitions		Contestable	Sewer laying is contestable where there is no reinforcement work being carried out as part of the scheme, and where Welsh Water are not required to serve a land entry notice. Where a sewer is laid by the developer, this will normally be done under a Sewer Adoption Agreement (see below).
Diversions of sewers and lateral drains		Contestable	Where the work is undertaken by a Developer Customer, Welsh Water will charge a supervision fee only. The supervision fee is non-contestable. In certain circumstances, we may require that we undertake some or all of the works ourselves to protect the integrity of our network, where the diversion works are directly affected by our network's operation, or where there are environmental risks presents. Any associated legal charges will also be non contestable.
Sewer Connections		Contestable	Where the work is undertaken by a Developer Customer, Welsh Water will charge a supervision fee only. The supervision fee is non-contestable. In certain circumstances, we may require that we undertake some or all of the works ourselves to protect the integrity of our network, where the connection works are directly affected by our network's operation, or where there are environmental risks presents.
