Hello

Welcome to the latest newsletter to update you on the progress that has taken place to restore Lisvane and Llanishen reservoirs.

In this newsletter we are highlighting some of the unique ecology of the site and how we would like your involvement.

Reservoir Update

It's been a busy few months on site since our last update with a lot of important and essential work having been done.

You may have noticed that some of this work - in terms of the timing and impacts on wildlife - has been directly challenged in recent weeks on social media. We just want to take this opportunity to explain what has been done and why and apologise for any concern this may have caused.

We have been creating a new drainage channel on site recently which is essential to help ensure the reservoirs operate safely in the future and also meet strict legal requirements. As part of this work, we had to manually cut back of areas of dense vegetation through February and March and had to remove some trees to clear a path. All work was supervised by an ecologist to monitor for bats and birds in any trees before being felled.

The new ditch has now been constructed, and as part of the work, a bund has been installed on the northern side to hold back some soil moisture, while various plants were transplanted to a safe area in advance of the work and two larger hibernacula were also formed, using dead wood and capped with soil. The area is now being allowed to regenerate by natural processes, apart from the most open part of the eastern woodland which have been replanted with woodland species to encourage regeneration of woodland ground flora. We will be continuing to monitor the area and working with the ecologist to explore adding other environmental enhancements.

We want to reassure you that this work was planned and carried out with the full approval from the relevant bodies but we do acknowledge that this should have been

communicated better so that we could have addressed many of your concerns. We will ensure this informs any future work.

Meanwhile, you may have also noticed that Llanishen Reservoir has begun to fill back up. With the recent dry weather this is taking longer than we initially anticipated, but we expect this to be completed by next year. We are pleased to see the local grass snake population, that over-winters in the reservoir, basking in the early spring sunshine from late-March onwards.

We still have a few more jobs to finish on the site which includes completing the building of a control booth, completing the electrical work in our pumping station, and installing a new access bridge at the northern end near to the allotments. We also need to do some maintenance work on the channels which bring surface water to the reservoirs to help keep them topped up. All in all we think we will have all of these jobs done by the end of June.



Did you know?

The 2019 Fungi Survey recorded a total of 25 species of waxcaps, which means the site still exceeds the SSSI selection criteria for fungi, whilst also recording the highest number of waxcap species since DCWW took over responsibility for the site.

Funding boost to become health and wellbeing hub

In January we received the good news that we'd been successful in a bid for a grant which will help the site become a hub for health & wellbeing.

Recognising the potential the reservoirs offer for promoting biodiversity and wellbeing, Welsh Water partnered with the Reservoir Action Group (RAG), Cardiff Council and Cardiff and Vale University Health Board to apply for a grant under the Welsh Government's 'Enabling Natural Resources and Well-being (ENRaW)' Scheme.

The grant will enable the development of facilities for the public to visit the site, a community engagement programme with volunteering, education and social prescribing strands. This includes creating conservation areas and a learning zone, installing foot paths, interpretation materials and bird

hides to view the variety of wildfowl that reside at the reservoirs. **Richard Cowie, Chairman of the Reservoir Action Group** said: "As a group that battled for over 15 years to save the reservoirs from a housing development, we are delighted to be working in partnership with Welsh Water, Cardiff Council and the University Health Board to ensure that this historically and ecologically important site is enjoyed and protected for generations to come".

Friends Group

We know that current social distancing measures mean we can't all get out and about, but that does not mean we can't still be planning for the future when things are a bit more back to normal.

That's why, over the coming weeks and months, we are hoping to support the formation of a Friends Group to help people get involved with the reservoirs and the site's heritage.

Prior to the site opening to the public, members of the group will have the chance to work with Welsh Water and co-create volunteering events that will help collate information for the new signage and interpretation scheme. Dependent upon social distancing measures, come autumn we hope our new friends will be able to help with conservation management activities to protect and enhance the unique ecology of the site.

Once opened to the public the Friends Group will continue to support Welsh Water to help care for the site; maximising opportunities for visitors to make use of the natural environment in order to benefit their wellbeing, encourage physical activity and volunteering.

Yn y cylchlythyr hwn, rydym yn sôn am beth o ecoleg unigryw'r safle a sut yr hoffem i chi gymryd rhan.

Newyddion am y Cronfeydd

Bu'n brysur ar y safle yn y misoedd ers y cylchlythyr diwethaf a gwnaed llawer o waith pwysig a hanfodol.

Efallai i chi sylwi bod peth o'r gwaith - o ran ye amseru a'r effeithiau ar fywyd gwylt - wedi'i herio ar y cyfryngau cymdeithasol dros yr wythnosau diwethaf. Hoffem fanteisio ar y cyfle i esbonio beth a wnaed a pham ac i ymddiheuro am unrhyw bryder a achoswyd.

Rydym wedi creu sianel ddraenio newydd ar y safle yn ddiweddar. Mae hon yn hanfodol i helpu i sicrhau bod y cronfeydd yn gweithio'n ddiogel yn y dyfodol ac yn bodloni gofynion cyfreithiol llym.
